Terms and Conditions

1. **Exclusive Photographer.** The Photographer shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer
2. **Deposit and Payment.** The Client shall make a deposit of 1/3 of the package price to retain Delahanty Photography to perform the services specified herein. At such time as this order is completed, the deposit shall be applied to reduce the total cost and Client shall pay the balance due. Final payment of the package fee is due 2 weeks before the date of the wedding.
3. **Cancellation.** If the Client shall cancel this Agreement thirty (30) or more calendar days before the wedding date, any payment paid to Delahanty Photography in excess of the 1/3 down payment shall be refunded in full. The initial 1/3 deposit is non-refundable.
4. **Photographic Materials.** All photographic materials shall be the exclusive property of Delahanty Photography. Rights to the proofs may be purchased and are included in certain packages.
5. **Copyright and Reproductions,** Delahanty Photography shall own the copyright in all images created and shall have the exclusive right to make reproductions. Delahanty Photography shall only make reproductions for the Client or for the Delahanty Photography's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Delahanty Photography's studio. If Delahanty Photography desires to make other uses, Delahanty Photography shall not do so without first obtaining the written permission of the Client.

6. **Client's Usage.** The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than Delahanty Photography. If Client is obtaining a print for newspaper announcement of the wedding, Delahanty Photography authorizes Client to reproduce the print in this manner. In such event, Client shall request that the newspaper run a credit for Delahanty Photography adjacent to the photograph, but shall have no liability if the newspaper refuses or omits to do so.
7. **Failure to Perform.** If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then Delahanty Photography shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Delahanty Photography. In the event Delahanty Photography fails to perform for any other reason, Delahanty Photography shall not be liable for any amount in excess of the retail value of the Client's order.
8. **Inherent Qualities.** Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Delahanty Photography from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
9. **Photographer's Standard Price List.** The charges in this Agreement are based on Delahanty Photography's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
